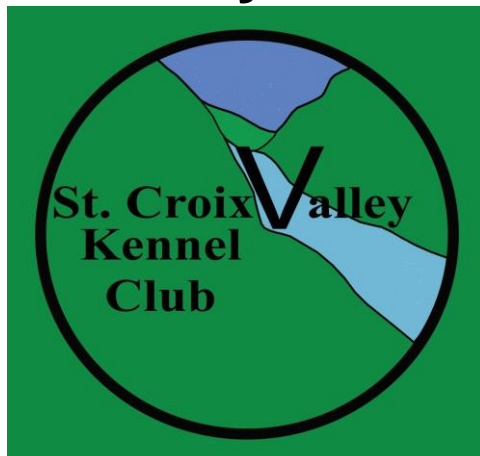

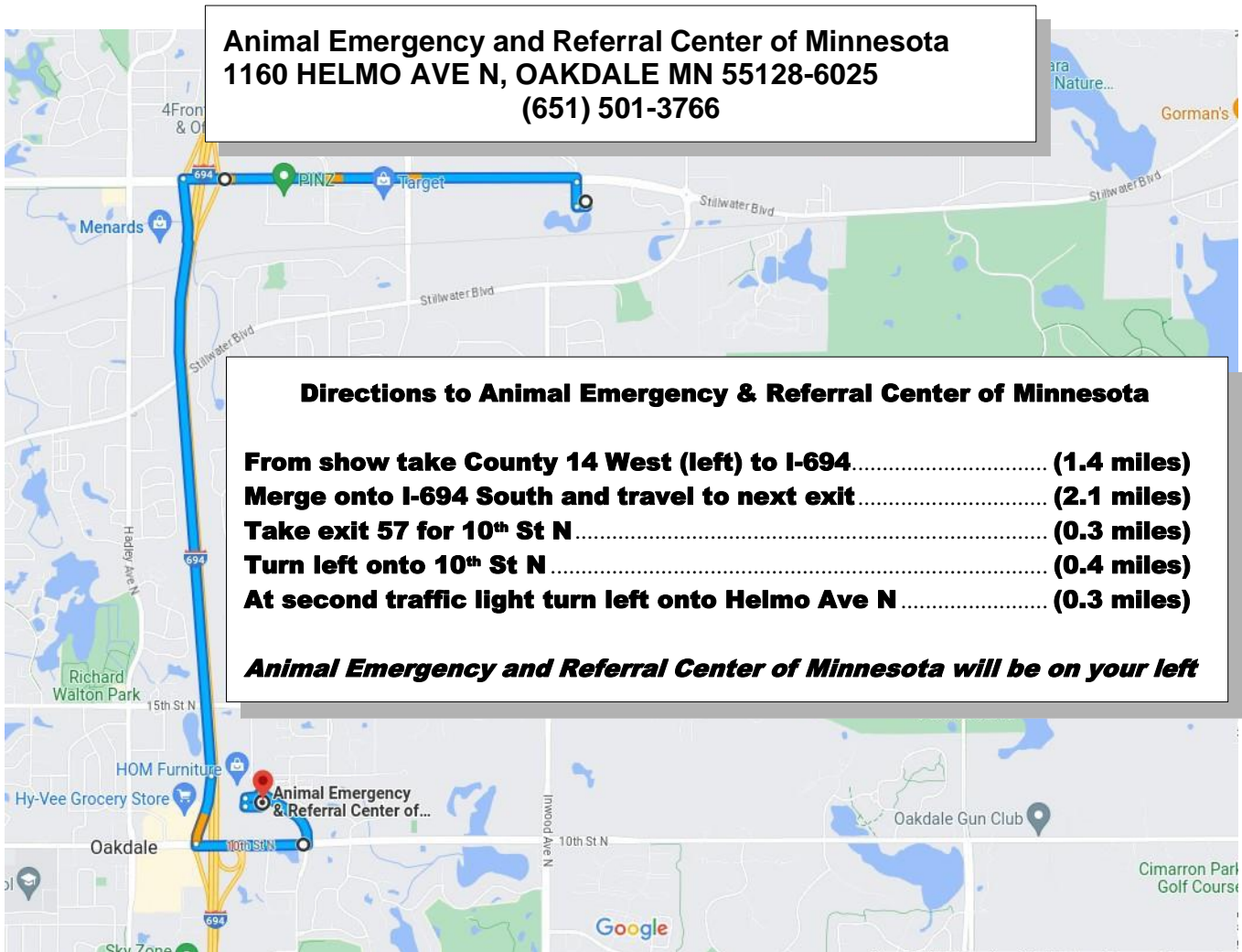

Entries specifying any conditions as to its acceptance will not be accepted. Entries received without fees or entries with post-dated checks will not be accepted. An additional \$15 collection fee will be due for each returned check.

CONFIRMATION OF ENTRY & JUDGING PROGRAM will be emailed (if legible on entry form) as soon as practicable. Should such acknowledgement not be received by the exhibitor within a reasonable time, notify the trial recording secretary at scvkc.obedience@gmail.com.

Please review confirmations carefully as no refunds will be processed for erroneous entries. Changes, additions, or corrections to entries must be received in writing prior to close of entries. Care will be taken to find duplicates, however if an entry has been processed, no refund will be made.

ROUTES TO THE SHOW SITE (8633 - 34th ST N, LAKE ELMO, MN 55042-8408)

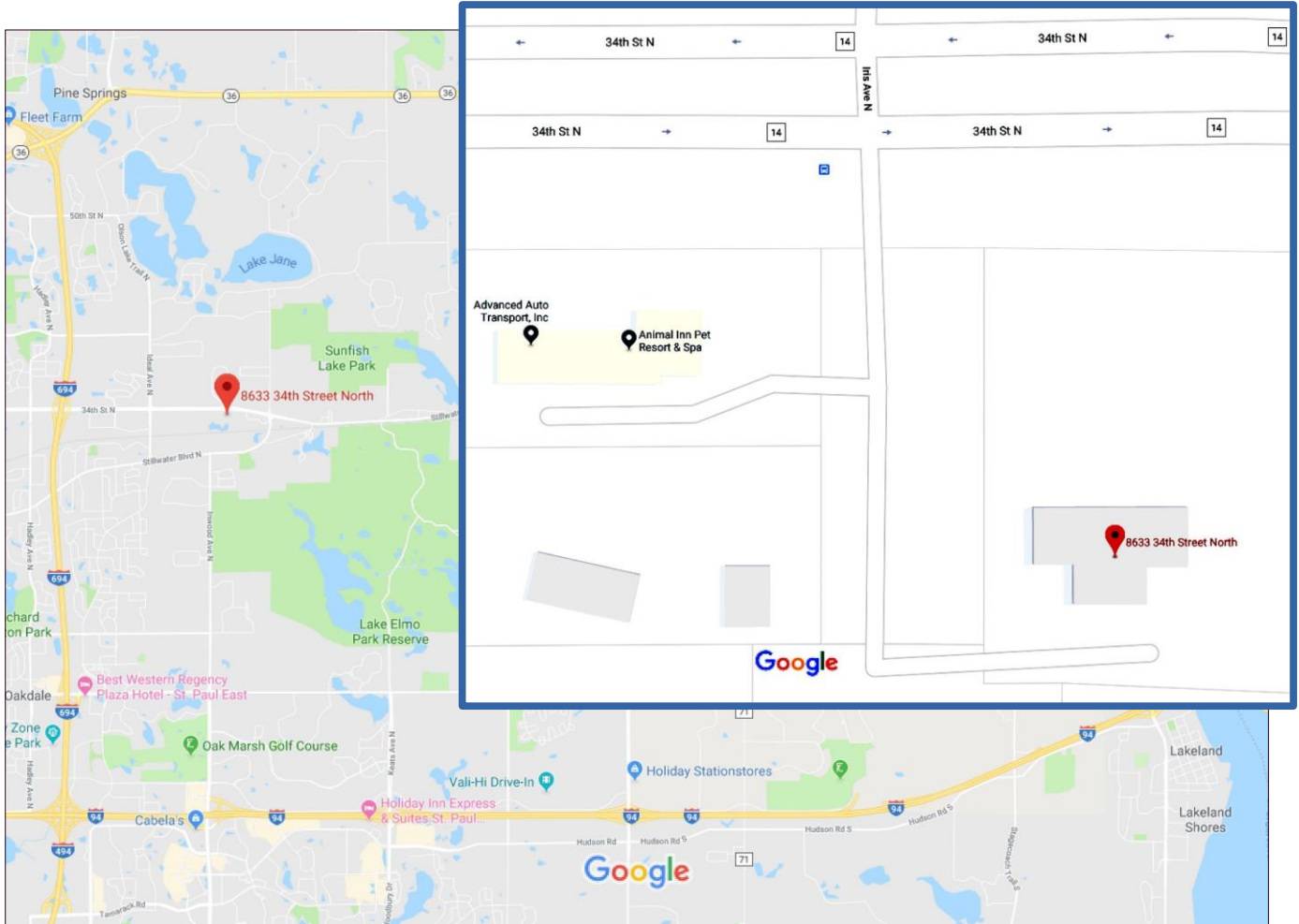
FROM THE NORTH: Take I-35 to I-35E. Take I-35E to I-694 East and then South to County 14 (Old Highway 5). Take County 14 East (left) and turn right at the Animal Inn sign.

FROM THE SOUTH: Take I-35 to I-35E. Take I-35E to I-494 East. Continue on I-694 North to County 14 (Old Highway 5). Take County 14 East (right) and turn right at the Animal Inn sign.

FROM THE EAST: I-94 TO I-694. Take I-694 North to County 14 (Old Highway 5). Take County 14 East (right) and turn right at the Animal Inn sign.

FROM THE NORTHWEST: Take I-94 to I-694. Take I-694 East and then South to County 14 (Old Highway 5). Take County 14 East (left) and turn right at the Animal Inn sign.

NOTE: The Animal Inn building is on your left at the end of the driveway.

Any abuse of the hotel/motel and their adjoining grounds brought to the attention of the club will be adjudicated by the Event Committee in accordance with AKC rules "Dealing with Misconduct" and may result in suspension.

NOTICE TO EXHIBITORS

An updated entry form is included which can either be printed and filled in with pen and ink, or filled out on a computer, and then printed and signed prior to mailing. The fields are largely the same as last year, with the order changed a bit, and one new field has been added. The "Notes to trial Secretary" is new this year and can be used for any additional information you would like to provide.

In addition to the non-regular Veterans class, we have added the non-regular Brace class to this year's Obedience trial. The Veterans class is for dogs that have an obedience title and are at least 7 years old. The Veterans class uses the Novice class standard of judging and exercises. The Brace class will be for two dogs of similar height at the withers, capable of performing the novice exercises. Dogs may be shown unattached or coupled. A separate official entry form will be completed in full for each dog entered. Exercises and judging will be as in the Novice class.

Limited crating space will be available and will require the use of mats under crates and chairs. Dogs may arrive any time prior to their scheduled judging. Dogs not required for further judging may be excused. Judges will not wait for any dog holding up a class. It is the responsibility of each exhibitor to have his/her dog ready at ringside without waiting to be called. Bitches in season are not permitted in the Trial. Exhibitors may request a refund of entries, minus a \$10 processing fee, for bitches that come into season after the closing date as long as the trial secretary is provided written documentation from a veterinarian at least 30 minutes prior to the beginning of the day's judging.

St. Croix Valley Kennel Club, INC. does not agree to arbitrate claims as set forth on the Official AKC Entry Form for these events. The St. Croix Valley Kennel Club, INC. assumes no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, their dogs or property and further assumes no responsibility for injury to an exhibitor's child. Entrants and spectators to this show do so entirely at their own risk. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. All dogs present must be held on leash or confined to their crates except when being judged. Any exhibitor, their dog and/or children who create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. Entry Fees will not be refunded for a dog that is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Trial Committee.

The well-being of dogs, exhibitors, and spectators is of paramount importance. Extreme weather conditions such as snow storms, hurricanes, lightning, extreme heat, must be considered for the health and safety of the dogs, exhibitors and spectators. No entry fees will be refunded if the trials cannot open, or be completed, due to extreme weather. Additionally no entry fees will be refunded if the show cannot open or complete due to civil disturbances or other acts beyond the control of St Croix Valley Kennel Club, Inc.

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons.
